# DESCRIPTION OF CAPABILITIES

#### **TECHNICAL SUPPORT**

SRL provided operational infrastructure and security protection support services, technicians, and analysts necessary to support ASM and the VA in addressing system security vulnerabilities components, ensuring information security risk controls are implemented and monitored, and in response to Federal Information Security Management Act (FISMA). VA's goal is to reduce the number of existing vulnerabilities to a level that removes a long-standing Material Weakness (MW) in its annual FISMA audit due to these security vulnerabilities.

#### **SECURITY SUPPORT**

SRL Provided Security Support Services to ensure MW and continued fears of the theft or leakage of Veterans' privacy information because of security vulnerabilities had attracted substantial negative attention from VA management, Congress, administration officials, and the public. In response to the MW findings from the FISMA annual audit, OI&T required support across OI&T (the Office of Information Security [OIS], and IT Operations and Services [ITOPS]) to support the implementation of all recommendations identified in the FISMA and FISCAM audits.

#### **RSS SUPPORT**

SRL delivered the operational infrastructure and security protection support services necessary to support VA in addressing system security vulnerability components, ensure information security risk controls are implemented and monitored, and adhere to FISMA and FISCAM audit reporting requirements.
